Notes:

1. The sizes of door leaf approved in this configuration fall within the size range for the single or double leaf doorsets, i.e. those without side panels or overhead panels. The maximum weight of an individual door leaf is 150 kg.
2. The resistance of the electro-mechanical locking and access control system to "non-mechanical" attack has not been assessed as it is outside the scope of PAS 24:2016. Certification does not cover the use of locks other than those listed.
3. The doorsets achieve a 'D' classification to PAS 24:2016.
5. The doorsets meet the requirements of a PPD1 classification for air permeability, a 1A (0) classification for water tightness and a PPD600B classification for wind loading as defined in BS EN 16361:2013+A1:2016.
6. The doorsets meet the requirements of BS EN 16005:2012 for a Class PPD3 classification for repeated opening and closing operation as detailed in BS EN 16361:2013+A1:2016.
7. Glazed doorsets are only approved when fitted with glazing units that include at least one pane of laminated glass complying with EN 356 P1A or higher.
